

OUR LADY OF LA SALETTE CATHOLIC SCHOOL TUITION AND FEES FOR THE 2011 – 2012 SCHOOL YEAR

KINDERGARTEN THROUGH GRADE EIGHT

Our Lady of La Salette School provides a Christ-centered, quality education in the Roman Catholic tradition. This ministry of education and formation strives to make a Catholic school education accessible to as many families as possible.

This revised Tuition Schedule for the academic year 2011-2012 is for students in **kindergarten through grade eight**. The generosity, service and sacrifice of parishioners, benefactors, staff, and school families make our school's ministry possible.

In addition to the tuition, there are other fees and discounts to be considered. Please take a few moments to review the following information when calculating your total expenditure and commitment.

REGISTRATION FEE

The registration fee is non-refundable.

Registration received on or before May 31, 2011	\$100 per family
From June 1 to July 31, 2011	\$125 per family
After July 31, 2011	\$150 per family

FUNDRAISING REQUIREMENT

Each family must sell a minimum of \$75 in raffle tickets for the Parish Fall Festival (September 2011) or make a \$75 contribution to the Parish Festival. Each family must also purchase or sell 2 tickets to the annual Parish Auction, to be scheduled during the first half of 2012. These fundraising contributions are required and will be added to the tuition account immediately after the festival and auction if they are not met.

ADDITIONAL FEES

These additional fees are non-refundable.

- The lunch supervision fee is \$50 per student.
- The graduation fee for incoming eighth graders is \$50 per student.
- The sacrament materials and retreat fee for each student preparing for First Eucharist, First Reconciliation or Confirmation is \$30.
- The lunch supervision, graduation and sacrament preparation fees will be added to the family's FACTS account. For families using the one or two payment plans, these fees are added to the family's account and are due either on May 15, 2011 (one payment plan) or November 15, 2011 (two payment plan).
- Twenty (20) service hours are required per family. \$10 per hour will be added to the tuition account for each service hour not completed by March 30, 2012.
- A \$20 service fee will be charged for each returned or unpaid check.
- Latchkey fees are separate from tuition. They appear on a separate schedule and must be paid in advance.
- School-sponsored extracurricular activities (such as field trips, band, dance, sports, etc.) will require additional fees.

DISCOUNTS

Tuition is discounted for registered members of Catholic parishes¹ in the Archdiocese of Detroit and for registered and qualifying members² of Our Lady of La Salette Parish.

① A family qualifies for the discount for registered members of Catholic parishes in the Archdiocese of Detroit by presenting a completed verification form to the school office.

② A family qualifies for a discount as a parish member of Our Lady of La Salette Church when all of the following conditions are met:

- The family is a *registered* parishioner of Our Lady of La Salette Church for no less than one year.
- The family *participates* in the ministries of the parish by offering their time and talent.
- The family *contributed* to the support of the parish and its ministries by donating at least \$825 in the Sunday Offering during the last calendar year. (January 1 through December 31, 2010).

PAYMENT PLANS

Our Lady of La Salette School offers **three** tuition payment plans. **ONE PLAN MUST BE CHOSEN**. Exceptions to these three options must be approved by the pastor.

- **PLAN 1:** One full payment of tuition and fees on or before May 15, 2011 (or within 30 days after registration for registrants after May 15, 2011).
- **PLAN 2:** Two half payments of tuition and fees paid on or before May 15, 2011 and November 15, 2011.
- **PLAN 3:** Ten monthly payments (June 2011 to March 2012) using the FACTS Management System direct bank account debit or credit card agreement.

With any plan and in all cases, all tuition and fees must be paid in full by March 31, 2012. No checks will be accepted for tuition and fees for the 2011-2012 school year after March 31, 2012. In the event of a withdrawal from the school, tuition will be pro-rated and refunded only for the quarters unattended. Refunds will be processed after all school property (textbooks etc.) has been returned. Report cards and progress reports will be withheld for accounts that are not paid in full, including all tuition, registration, supervision, graduation, fundraising, and latchkey fees.

Note: The information on this page and the tuition schedule on the other side supersede any and all other published information regarding tuition, fees and payment plans for Our Lady of La Salette School for the 2011-2012 school year.

TUITION ASSISTANCE

The Archdiocese of Detroit has a tuition assistance program for registered Roman Catholic families funded by the Stewards for Tomorrow effort. Several other programs also provide tuition assistance. The parish occasionally has tuition assistance available from friends and benefactors. All families requesting tuition assistance must complete the FACTS financial aid form.
